V organizaciji Slovenskega gospodarskega in raziskovalnega združenja in Evropske komisije je 3. aprila 2019 na **Ekonomski fakulteti Univerze v Ljubljani** potekala zelo uspešna konferenca **BOOSTING INNOVATION FOR EU INDUSTRY: Industrial Infrastructures & Open Innovation Ecosystems**. Visoki predstavniki Evropske komisije so predstavili različne instrumente in aktivnosti za spodbujanje inovacij v podjetjih, kot so Digital Innovation Hubs, Innovation Test beds, spodbujanje v programu COSME, spodbujanje inovacij v prihodnjem programu InnoFin ter prihodnji program spodbujanja prehoda na digitalno družbo. V okviru konference je Evropska komisija uradno predstavila tudi pravkar lansiran Evropski inovacijski svet (EIC), ki bo v prihodnjem finančnem obdobju spodbujal disruptivne inovacije. V organizaciji Slovenskega inovacijskega stičišča, ki je partner konference, je potekala tudi produktivna razprava o inovacijskem ekosistemu v Sloveniji.

Na konferenci je sodelovalo okoli 200 udeležencev iz enajstih držav, ki so slišali tudi predstavitve 18 odličnih primerov odprtih inovacij iz podjetij, podjetniških združenj, grozdov, raziskovalnih organizacij in univerz. Konferenca je predstavljala tudi odlično priložnost za razpravo in mreženje. Poleg 38 uradnih bilateralnih sestankov so imeli udeleženci veliko priložnosti za mreženje med odmori in kosilom.

Glavni sklepi konference so pozivi k izboljšanju nacionalnega in EU inovacijskega ekosistema ter uvajanje spodbud, ki podjetjem omogočajo dostop do odprtih inovacijskih ekosistemov, ki jim pomagajo pri razširjanju njihovih inovacij na trg, ponujajo dostop do financiranja, digitalnih tehnologij ter opreme za testiranje in certificiranje inovativnih produktov in storitev.

➤ **Revizorje Evropskega računskega sodišča skrbijo nepravne obveznosti Evropske komisije za evropske projekte**

Revizorji Evropskega računskega sodišča opozarjajo, da so neizplačane obveznosti iz proračuna EU za evropske projekte dosegle novo rekordno raven, ki bi v prihodnje lahko povzročila bistvena finančna tveganja. Vrednost plačil, ki jih bo Evropska komisija dolguje, je konec leta 2017 znašala 267 milijard

evrov in bo verjetno še naprej rasla. Vse večji zaostanki pri izvrševanju proračuna bi po besedah revizorjev lahko vplivali na prihodnje projekte, ki jih financira EU, opozarjajo revizorji.

Letni proračun EU sestavljajo zneski, ki so v zadevnem letu na voljo za prevzem obveznosti, in zneski, ki so na voljo za dejanska plačila. Tako imenovane neporavnane obveznosti so obveznosti, prevzete v tekočem in prejšnjih letih, ki še niso bile plačane ali preklicane. Neporavnane obveznosti so se v zadnjem desetletju povečale za več kot 90 odstotkov, pri čemer je vidna pospešena rast v zadnjih letih.

Revizorji opozarjajo, da je glavni izziv, kako zagotoviti, da se v novem večletnem načrtu porabe za obdobje 2021–2027 ne bodo začele kopičiti še večje neporavnane obveznosti. Zato predlagajo možne rešitve.

➤ Partnerji v projektu AVENUE razvijajo avtonomni električni minibus, ki bo pobiral potnike na zahtevo kot taksi

V Bruslju je bilo mogoče v sredo, 3. aprila, preskusiti avtonomni električni minibus, ki so ga razvili v okviru evropskega projekta AVENUE. Enake minibusse že uvajajo v Kopenhavnu, Ženevi, Luksemburgu in Lyonu. Posebnost minibusov, ki so ga razvili v okviru projekta AVENUE, v primerjavi z avtonomnimi minibusov, ki so že v uporabi v različnih krajih po svetu, je, da ne vozi po vnaprej določeni progi, ampak pobira potnike na zahtevo kot taksi. Ustavi se tudi na zahtevo in izbira najustreznejšo pot med postanki.

Cilj projekta AVENUE je dokazati, da so avtonomni minibusov možna rešitev za javni transport v mestih in predmestjih. Med cilji projekta je tudi določitev ovir, ki jih je še treba odpraviti. Partnerji v projektu razvijajo sistem avtonomnih vozil, ki je mišljen prej kot razširitev kot nadomestitev javnega prometa v mestih. Uporabnikom naj bi na primer omogočil, da bi jih minibus pripeljal do najbližje postaje javnega prometa – ne prezgodaj in tudi prepozno ne. Prebivalcem bi bil na voljo tudi za vožnjo po soseski, kar bi koristilo predvsem ljudem z omejitvami pri gibanju.

V okviru projekta prav tako razvijajo računalniško programsko opremo za upravljanje voznega parka avtonomnih vozil v obliki platforme, ki jo bodo izvajalci javnega prometa lahko dodali svojim obstoječim sistemom. K mestom, v katerih avtonomni minibus že vozi, bodo dodali nova in kmalu bodo začeli zbirati prijave. Iskali bodo mesta, kjer je vsaj eno vozilo že v uporabi.

➤ **Dogovor EU o prihodnjem programu za raziskave in inovacije Obzorje Evropa**

Države članice EU so v okviru Sveta EU potrdile skupno stališče o večini operativnih določb programa Obzorje Evropa, ki je okvirni program EU za raziskave in inovacije za obdobje 2021–2027. V dogovoru je predvideno, da lahko Evropski svet za inovacije pod določenimi pogoji zagotovi tudi podporo samo v obliki nepovratnih sredstev ali podporo samo v obliki lastniškega kapitala. Kar zadeva naloge, dogovorjeno besedilo ne določa le podrobnejših pogojev, temveč vsebuje tudi seznam področij, na katerih bi se lahko vzpostavile naloge in partnerstva. Priznana je odločilna vloga držav članic pri opredelitvi prednostnih nalog na področju raziskav in inovacij. In ne nazadnje, okrepljene so določbe o širitvi sodelovanja. Zdaj so na vrsti pogajanja med Svetom EU in Evropskim parlamentom.

➤ **Evropski parlament je sprejel direktivo, ki predpisuje prepoved uporabe izdelkov iz plastike za enkratno uporabo do leta 2021**

Evropski parlament je potrdil direktivo, ki prepoveduje plastične predmete za enkratno uporabo, kot so krožniki, pribor, slamice in vatirane palčke do leta 2021. Nova direktiva prav tako predpisuje, da bodo države članice morale do leta 2029 doseči 90-odstotni cilj zbiranja plastičnih steklenic. Plastenke bodo morale do leta 2025 vsebovati najmanj 25 odstotkov recikliranih materialov, do leta 2030 pa 30 odstotkov teh materialov. Proizvodi, obravnavani v novi direktivi, predstavljajo 70 odstotkov vseh predmetov v morskih odpadkih.

Nova direktiva uvaja tudi razširjeno odgovornost proizvajalca za cigaretno filtre in ribiško opremo. Za ribiško opremo to pomeni, da bodo proizvajalci in ne ribiči tisti, ki bodo nosili stroške pobiranja mrež, izgubljenih v morju.

Zdaj morajo direktivo potrditi še države članice v okviru Sveta EU, ki med evropskimi institucijami predstavlja države članice. Po objavi v uradnem listu bodo imele države članice dve leti časa, da bodo določbe direktive prenesle v svojo nacionalno zakonodajo.

Po podatkih Evropske komisije predstavlja plastika več kot 80 odstotkov morskih odpadkov. Proizvodi, obravnavani v novi direktivi, sestavljajo 70 odstotkov vseh predmetov v morskih odpadkih.

➤ **Vzpostavljena sta platforma za varnejši promet in nov mehanizem mešanega financiranja za prometni sektor**

Evropska komisija in Evropska investicijska banka (EIB) sta vzpostavili platformo za varnejši promet ter nov mehanizem mešanega financiranja za prometni sektor v okviru instrumenta za povezovanje Evrope (CEF). Prek platforme bosta spodbujali varnost kot ključni vidik naložb v prometu ter omogočali lažji dostop do tehničnega in finančnega svetovanja, zlasti glede varnosti v prometu. Mehanizem mešanega financiranja z začetnim proračunom v višini 200 milijonov evrov pa bo usmerjen zlasti v uvajanje evropskega sistema za upravljanje železniškega prometa (ERTMS). Člani lahko na SBRA dobijo dodatne informacije.

Med projekti za povečanje prometne varnosti bo posebna pozornost namenjena povečanju varnosti v cestnem prometu, saj na evropskih cestah še vedno umre preveč ljudi in preveč je tudi š>e vedno poškodovanih v prometnih nesrečah. Evropska komisija in EU bosta podpirali naložbe v ciljne ukrepe za povečanje prometne varnosti.

Mehanizem mešanega financiranja bo poleg uvajanja mehanizma ERTMS usmerjen tudi v uvajanje infrastrukture za alternativna goriva. Finančna podpora prek tega mehanizma bo na voljo od marca 2021, torej z uvedbo novega finančnega okvira EU za obdobje od leta 2021-2027.
